

Comprehensive Services Portfolio

Logistics project management setup – Includes logistics options analysis and market engagement

Regulatory compliance assessments – Includes assessments and guidance for North American CFR49 and Europe IAEA requirements plus local impact assessments (based on intelligence resulting from memberships of WNTI, WNA and other working groups).

International and national route selection – Options based on considerations given to cost, risk, and country restrictions

Road or rail provider selection – Options based on provider capability and location

Liner selection and port acceptance – Includes training for new ports and liners to open new routes

Charter vessel management – Includes stow plan preparation and interface controls

Package supply (rental or sale) and delivery – Includes guidance on specifications, plus provision of package equipment (from TAM or independent suppliers).

Contents restraint management – Includes developing / endorsing contents and package restraint systems against applicable regulations for Class 7 and non-Class 7 **Equipment Rental** –Includes ISO containers, flatracks and stowage systems from TAM's inventory of equipment.

Customs clearance, foreign transit permit management – Includes managing Competent Authority requirements for in country demands on package licenses and permits

Product storage management and delivery at feed rates – Includes identifying storage facilities for active/non active cargo and coordination of all environmental permit requirements

Transport services – Includes barge transport, feeder vessel transport, ocean liner transport; charter or part charter vessel ocean transport; road and rail collection and delivery. Transport options are available for heavy containerized cargo or roro noncontainerised cargo in low quantity or high quantity (trucks or vans).

ISO devanning and vehicle change management for goods inward restrictions – Includes providing support for undeliverable consignments to depots where space is restricted

Transport event or package condition crisis management – Includes carrying out full investigations for any incidents that occur to establish root causes and present reports to nuclear site customers



Shipment surveillance – Includes offering initial surveillance, final surveillance or 100% surveillance for shipments by road, sea or rail

Empty package sales – Includes offering customers the opportunity to sell their shipping containers in any country after deliveries are complete

On-site Logistics Support – Includes offering logistics inventory control resources to customer sites to provide shipment documentation or coordinate the logistics process for domestic and international export/import shipments
